



Victory at the Washoe County Board of County Commissioners 12/14/2021

Good morning, fellow Nevada Patriots!

We have good news to report. The county commissioners voted 3-2 in favor of ending the county emergency declaration (declared by the County Manager on 3/16/2020 and ratified by the BCC on 3/31/2020).

I briefly perused the YouTube video of the 3/31/2020 meeting. It was interesting to contrast the high anxiety evident in the commissioners' voices and demeanors to that which they exhibit today. Bottom line: there never really was an "emergency." Many were hoodwinked. Many were awakened. Many thumbed their noses at the nonsense and either continued their lives or got busy - Melanie & Mark Sutton of NV Grassroots Patriots and Erin Massengale of the Freedom Angels & Health Freedom movement were in the latter - they got busy. I'm grateful to have joined their efforts, along with many of you, as we have assertively engaged the Washoe County commissioners, school district and health district since last year and challenged them to honor their oaths to the Constitution.

Despite the lifting of the county emergency declaration yesterday, the state declaration remains in place. We will have a brief respite over the holidays to rest & reorganize. We will be working on the next step in our strategy to nullify the Governor's unconstitutional mandates. **My goal has ALWAYS been to restore Constitutional governance and to get the boot of government off ALL of our necks!** We are all stakeholders in achieving that lofty goal. It is a daunting task, but we are American





Patriots - we are NEVADANS! We have the guts, the grit, the unity of purpose and focus to achieve this.

The American Revolution was fought over the span of 8 years. In this culture of 2:20 minute TikTok videos and instant gratification, the notion of victory taking that long may dissuade some folks to engage. I meet this challenge one day at a time. For the county, this is especially problematic; the county manager is an unelected bureaucrat, only accountable to the county commission. If the county commission is not held to account for their duty to the citizenry, we have tyranny.
